Buyer agrees to take good care of this kitten so as to provide food, shelter, healthy and stimulating environment, routine medical care, exercise and affection. This animal will be kept indoors and not be allowed to roam freely outdoors with out supervision.

Maplewood Bengal's must be contacted if at any time during the kitten's/cat's life the buyer is no longer able to keep the kitten. Under no circumstances will this animal be surrendered to an animal shelter, pet store or sold/given to another family or buyers family member, if this becomes necessary the animal must be surrendered to the breeder who will place it in a loving home.

This kitten is a purebred SBT Bengal.

This kitten is in good health and has been examined by a veterinarian and received its first set of shots.

The kitten is guaranteed to be free of communicable diseases for a period of 72 hours from the date of sale, and must be seen by a veterinarian in this time, this is the health guarantee period (this will be null and void if not seen by a vet in 72 hours). The cat/kitten will be guaranteed free of genetic defects for 2 years. If that said defect is evidenced in the first 2 years a licensed Veterinarian must document it through written report or an autopsy report. The purchaser is obligated to immediately spay or neuter this cat/kitten. Upon supplying the breeder with this documentation the breeder will replace the kitten with one of the same quality. By signing this contract the purchaser is also signing permission for their vet to disclose any information on the Maplewood cat/kitten and all cats or kittens living with the cat/kitten. The buyer is responsible for all veterinary costs.

Buyer agrees to never vaccinate against FIP. Buyer agrees to vaccinate using only a killed vaccine.

Our Cattery will accept any Maplewood kitten within the first three days from the date of sale with a refund less \$100 from the purchase price. The kitten must have a health certificate issued no more than two days prior to the date of return if more than three days have lapsed.

**Breeding and show cats:**

The seller does guarantee fertility in this breeding animal with the exception of problems caused by pyometria which the breeder has no control over. If this cat has not produced viable offspring by the age of 20 months, after being serviced by at least 2 proven studs or queens which ever the case may be the seller agrees to replace the cat with one of equal value, upon proof of spay/ neuter by a licensed veterinarian. The seller does have the right to, at their cattery attempt to breed the cat first, before a replacement cat is given.

Purchaser does understand that the breeder does not guarantee championship titles.

If a male breeder is purchased he must be neutered before he is placed in another home and his placement must be approved by the breeder.

Buyer agrees that no stud service will be done with any outside cats. The buyer may only breed their own females. No outside co-owns on this male

If a female breeder is purchased she must be bred with either with a Maplewood stud or another stud that is approved in writing by breeder. Kittens of a female breeder can only be sold as pets or show not as breeders. When retired, she must be spayed before being placed in another home.

Registration papers will be given when breeding rights are paid for in full.
